Selection of candidates shall be based on:

- 1) Performance in Qualifying Examination;
- 2) Valid GATE/CEED/UGC-NET (JRF) Score, as applicable;
- 3) Physical Interaction, and
- 4) Work Experience

General Instructions:

1. Application fee is ₹3,500/- (Non-refundable), for Indian Nationals. For reserved categories SC, ST, and PwD categories, the application fee is ₹ 1750/- (Non-refundable).
2. The Foreign Nationals/ NRI/ PIO/OCI seeking admission in any of the Postgraduate Courses shall apply separately through DASA 2026 portal.
3. Candidate can exercise **any number of choices based on eligibility for the course applied for in any of the Institutions**.
4. Admission to Post Graduate Degree Courses against Kashmiri Migrant Reserved Seats as per the rules over and above the total number of PG seats of the respective Institute.

5. 5% seats are reserved for persons with benchmark disabilities on horizontal basis. These shall be adjusted against the respective reservations for OG, SC, ST, EWS and OBC (NCL) Categories as per provision for PwD reservations, Government of India.
6. Institutions reserve the right to give admissions for supernumerary seats as applicable/as per GoI norms.
7. Only GATE and CEED qualified candidates (in appropriate branch) having valid Score Card shall be eligible for the scholarship.
8. Institutions reserve the right to reject/cancel any application without assigning any reason.
9. Candidates in final year/semester are also eligible to apply..
10. Sponsored candidates from Government organizations, quasi-Government organizations, PSUs shall apply separately through the websites of respective Institutions.
