4. Brief description of Prequalification criteria :

- 1. The bidder should be an Indian registered company engaged in the job of implementation of ERP for minimum of 3 years in India as on 31st March 2018.
- The Bidder must have successfully implemented at least 3 ERP projects of an average value of Rs. 20.00 lakhs during the last three completed financial years out of which at least one ERP project should be from CFTI type institution as on 31st March 2018.
- The Bidder should have a minimum average annual turnover of at least Rs. 50 Lakhs in last 3 years duly certified by Chartered Accountant (Annual Return/Balance sheet of last three years (FY 15-16,16-17 & 17-18) (document need to be attached as proof).
- 4. The bidder should submit an undertaking for neither have been Debarred and / or blacklisted by any Central / State Govt. Department / Universities / Educational Institutions/Organization etc. nor should have any litigation/ enquiry pending and / or initiated by any of these Department or Court of Law.
- 5. PAN No. and GSTIN Registration Certificate and any other relevant certificate required from concern authorities shall be submitted.
- 6. Bidder must submit a Solvency certificate of Rs. 5.00 lakhs from the Nationalized Bank.
- 7. Atleast two letters of reference from past customers together with contact, address etc. showing past performance in the execution of projects of a comparable nature and complexity.
- 8. Bidder shall have to enclose documentary evidence in support of prequalification Criteria. In absence of such documents, application will be summarily rejected.

5. Other requirements and Important Terms and Conditions
