1.	<p><b>Applicability:</b></p> <p>Public Works Organization or the Public Sector Undertakings, Universities, IIT's and similar autonomous organizations such as ICAR,CSIR,ICMR etc. those who are authorized for execution of similar type of work. Any Individual, Sole Proprietorship Firm, Partnership Firm, Public Limited company or a Private Limited Company may also apply for empanelment as a "Structural or MEP Engineering Consultant or Project Management Consultant" under these rules provided the eligibility criteria and other conditions are satisfied. The empanelled "Structural Consultant" or "MEP Consultant" or Project Management Consultant" or With combination of the consultancy services has to abide by all the rules made herein and as amended from time to time, during the tenure of their empanelment.</p>
2.	<p><b>Scope of Work:</b></p> <p>a) <b>For Structural Consultant:</b> The scope of work includes but is not limited to preparation of detailed Structural Design preparation of GFC drawings, preparation of tender documents, BOQ and detailed specifications for the internal and external works, Utilities and evaluation of works. Submission of "as built drawing" and obtaining completion certificate from statutory authorities. The structural design made by the consultant shall be proof checked for structural stability wherever applicable by third party approved agencies at his cost.</p> <p>b) <b>For MEP Consultant:</b> The scope of work includes but is not limited to preparation of detailed MEP design, preparation of GFC drawings, preparation of tender documents, BOQ and detailed specifications for the internal and external works (CCTV, Fire detector &amp; Alarm, Access Control Computer Network etc), Utilities and evaluation of works. Submission of "as built drawing" and obtaining completion certificate from statutory authorities.</p> <p>c) <b>For Project Management Consultant (PMC):</b> The scope of work includes but is not limited to preparation of Detail Project Report, Action Plan, Bid Management Process including preparation</p>

	of Tender Documents, BOQ and Detailed Specifications and Contract document, Execution Plans, Construction Project Management reporting, for the internal and external works of buildings.
3.	<p><b>Scope of Empanelment:</b></p> <p>The empanelment in SPA-Bhopal will entitle the “Structural Consultant” or “MEP Consultant” or “Project Management Consultant” or combination of these consultancies to be considered for the consultancy project undertaken by the SPA-Bhopal. It shall not confer any right on the consultant either to be necessarily issued with the tender documents or for award of work.</p>
4.	<p><b>Empanelment Procedure:</b></p> <p>The consultant has to submit the prescribed application, complete with all documents to SPA-Bhopal.</p> <ul style="list-style-type: none"> <li>• Incomplete applications and application without prescribed documents are liable to be rejected.</li> <li>• SPA-Bhopal will have the right to independently verify the details furnished by the consultant and to get the works completed by him/her/them, inspected and / or obtain such other reports as may be considered necessary. For this purpose SPA-Bhopal may constitute necessary inspection team(s).</li> <li>• SPA-Bhopal reserves the right to limit the number of architects and consultant to be empanelled in any category.</li> </ul>
5.	<p><b>Validity of Empanelment:</b></p> <p>The empanelment will be valid for a period of three years from the date of empanelment. However, the empanelment may be revalidated, in accordance with the rules in this regard. Each revalidation shall be for a period of one year from the date of expiry of previous empanelment / revalidation. The empanelment shall be open for review by the SPA-Bhopal and liable to termination, suspension, or any other such action at any time, if considered necessary, by the SPA-Bhopal after issue of due notices to the consultants.</p>
6.	<p><b>Category of Empanelment:</b></p> <p>The empanelment shall be done for the following categories:</p> <ol style="list-style-type: none"> <li>a. Category A - Works with estimated cost upto ₹ 10 Cr.</li> <li>b. Category B - Works with estimated cost above ₹ 10 Cr. to ₹ 50 Cr.</li> <li>c. Category C - Works with estimated cost above ₹ 50 Cr.</li> </ol>
7.	<p><b>Change In Constitution of Firm:</b></p>

	<p>The empanelled consultant / firm shall not modify the existing partnership or enter into any fresh partnership without the prior approval of SPA-Bhopal. Such proposal, if any shall be submitted in advance giving full details of the intended changes and drafts documents like partnership deed, articles of association etc. as applicable. Any change in the status of the consultant without prior approval, will render the consultant to be removed from the approved list of consultant.</p>
<p>8.</p>	<p><b>Change of Address:</b></p> <p>While Applying for empanelment the consultant should mention address of his registered office as well as Head office, if different. All documents viz. Bankers certificate etc should bear one of the addresses; otherwise the same shall not be accepted. The consultant shall intimate the change, if any, in any of the addresses mentioned in the original documents, in advance or within one month of such change along with acknowledgement of noting down of such change in address from the Bank, Income Tax authorities, Sales Tax authorities etc. Failure to do so may result in removal from the approved list of consultant.</p>
<p>9.</p>	<p><b>Submission of Tenders:</b></p> <p>Empanelled consultant shall take part in the tendering process of SPA-Bhopal. Consultants are liable to be removed from approved list if they do not secure works in SPA-Bhopal / do not take part in tendering process. For this purpose the approved list shall be periodically reviewed with reference to the number of tenders received for the various works.</p>
<p>10.</p>	<p><b>Consultant's Obligations:</b></p> <p>The "Structural Consultant" or "MEP Consultant" or "Project Management Consultant" or combination of these consultancies should fulfill all his/her obligations specified under these rules within the time and in the manner as specified. Some of the obligations are</p> <ol style="list-style-type: none"> <li>a. Prior approval shall be obtained before modifying the constitution of the firm/ company.</li> <li>b. Intimation regarding change of address should be given in advance or within one month along with documentary proof bankers, Income Tax Department, States Tax Department and service tax etc.</li> <li>c. Consultant should be registered with all the required Govt. statutory bodies during the period of empanelment / revalidation.</li> <li>d. Empanelled consultant shall maintain good conduct while carrying out work and shall not indulge in unethical practices.</li> </ol>

	<ul style="list-style-type: none"> <li>e. The works awarded should be executed strictly as per terms and conditions of contract.</li> <li>f. Top priority should be accorded for timely submission of drawings, design calculation and BOQ etc.</li> </ul>
11.	<p><b>Removal From Approved List:</b></p> <p>The name of the “Structural Consultant” or “MEP Consultant” or “Project Management Consultant” or combination of these consultancies may be removed from the approved list by SPA-Bhopal, if the consultant</p> <ul style="list-style-type: none"> <li>a. Has more than one occasion, failed to execute a contract or has executed it unsatisfactorily; or</li> <li>b. Is proved to be responsible for design calculation mistake in two or more works; or</li> <li>c. Persistently violates any important conditions of contract; or</li> <li>d. Fails to abide by the conditions of empanelment; or</li> <li>e. Is found to have given false particulars at the time of empanelment; or</li> <li>f. Has indulged in any type of forgery or falsification of records; or</li> <li>g. Changes the constitution of the firm or individual without prior approval of SPA-Bhopal; or</li> <li>h. Changes permanent address / business address without intimation to SPA-Bhopal; or</li> <li>i. Is declared or is in the process of being declared as bankrupt, insolvent, wound up, dissolved or partitioned; or</li> <li>j. Is involved in complaints of serious nature received from other departments which prima facie appear to be true; or</li> <li>k. Default in settlement of tax dues like GST, income tax, contract tax, sales tax, octroi, duties etc;</li> <li>l. Is considered not required to be in the approved list for any other reason considered by SPA-Bhopal.</li> </ul>
12.	<p><b>Consultancy Services, Eligibility Criteria &amp; Related Details:</b></p> <p>Interested organizations who have rendered Structural or MEP Engineering Services or Project Management Consultancies for Building Project and Industrial Building Projects may submit their offer in the manner indicated below.</p> <p><b>Eligibility Criteria and procedure for submission of proposal:</b></p> <p>The “Structural Consultant” or “MEP Consultant” or “Project Management Consultant” or a combination of these consultancies should satisfy the minimum <b>eligibility criteria specified in table-1,2,3,4,5,6,7,8,9.</b></p>

- a. The criteria for experience shall be the completion of at least 5 numbers of works of prescribed nature as specified in the categories and magnitude as a Structural or MEP consultant during the last 5 years.
- b. The consultant having experience in Structural or MEP retrofitting projects in the prescribed categories in the last 5 years may consider for the retrofitting projects.
- c. The works should have been executed in same name and style in which the empanelment is sought. Certificate of the completion of works are required to be submitted.
- d. The financial soundness shall be judged on the basis of the average annual business turnover (in terms of consultancy fees received) in the last 3 years.
- e. The “Structural/MEP/PM Consultant” shall have to pay a non-refundable processing fee by crossed demand draft drawn in favor of **School of Planning Architecture Bhopal** payable at Bhopal from any scheduled bank or in favor of “**SPA Bhopal Internal Receipts**” Account Number - 2073201002565, IFSC- CNRB0004725 through NEFT/Online transactions prescribed. The processing fee for CATEGORY -‘A’, CATEGORY -‘B’ & CATEGORY -‘C’ is Rs.3000/-, Rs.4000/- , Rs.5000/- respectively.
- f. This fee has to be submitted along with the application form. Scanned copy of the payment receipt to be uploaded on the website/hardcopy.
- g. A duly attested photocopy of the PAN number, GST registration number and registration with statutory bodies to be submitted along with the application.
- h. In case of works carried out for private Organization’s / persons copies of TDS certificate along with a copy of performance report with work order / agreement should be enclosed. Private works without performance report and TDS certificates shall not be considered for evaluation.
- i. All the documents as desired to be submitted in the form of hardcopy. Incomplete Applications will be summarily rejected. SPA-Bhopal reserves the right to accept or reject any application without assigning any reason
- j. Consultant has to apply separately for different Category, if interested, In case an application is found suitable for empanelment in Category lower than the one applied for, the empanelment may be done in the eligible Category in respect of such consultant.

	<ul style="list-style-type: none"> <li>k. The empanelment shall be valid for a period of 3 (three) years. The panel may be extended further at the discretion of SPA-Bhopal.</li> <li>l. Consultant(s) / Firms having experience in designing Green Buildings as per GRIHA norms or Equivalent recognized international norms should give details of such works carried out by them in the last five years.</li> <li>m. The Application should be on the prescribed form. All Annexure duly completed should be submitted. The Annual turnover of the firm and profit and loss statement by way of Professional Fees for Consultancy for the last three years, duly audited by a Chartered Accountant, should be submitted. Certified copies of Award letters, completion certificates etc should be enclosed.</li> <li>n. Summary of regular/permanent professional employees and key Personnel including the nature of specialization, qualifications and experience should be enclosed along with certificates.</li> <li>o. Applicants should give an undertaking certifying that the firm has not been blacklisted by any Govt. /Local bodies/PSUs.</li> <li>p. Empanelled Structural or MEP Consultants would be entitled to tender for Structural or MEP consultancy works in SPA-Bhopal and work shall be awarded to successful tenderers on General Terms and Conditions of the bid.</li> </ul>
13.	<p>The Structural Consultant or MEP Consultant is required to apply for the empanelment in their respective category. However, a joint consultancy work may be applied in the category of Structural, MEP and Project Management Consultant with no separate fee under the clause 12 e subject to other eligibility criteria's.</p>



**Receipt and opening of proposal-** Proposals should be submitted for consultants in Two bid system with technical and financial bids sealed separately. The bidder should put these two sealed envelopes in a bigger envelop duly sealed and submit the same to the **Registrar School of Planning and Architecture Bhopal Bhauri Madhya Pradesh – 462030, by 20<sup>th</sup> December 2024, 05.30 p.m By Post/By Hand**. Late EOI/bids i.e. EOI/bids received after the date and time as specified above, should not be considered. Without processing fee of EOI shall not be considered and will be summarily rejected.

**Methods of Empanellment -**

The basis of selection of the consultant shall follow any of the methods given in GFR 2017 Rule 192 to 194 as appropriate for the circumstances in each case.

Bidders shall be empanelled on the basis of eligibility criteria given in the tables below.

The Final selection of the emapnelled consultants for award of work for any project shall follow the design basis report and presentation and; the financial quote.

**Monitoring the Contract-**The Ministry/Department should be involved throughout in the conduct of consultancy, preferably by taking a task force approach and continuously monitoring the performance of the consultant(s) so that the output of the consultancy is in line with the SPA Bhopal’s objectives.
