#### **Sub: Announcement of Award of Scholarship to Under Graduate students.**

SPA, Bhopal award 'Merit-cum-Means' scholarship to our Under-graduate students of Architecture and Planning. All the Under Graduate students who were admitted in the academic year 2012-13, 2013-14, 2014-15 and 2015-16 eligible to apply for these scholarships.

#### **A. Merit cum-means Scholarship based on performance and family income.**

#### **(A)-Merit cum-Means:-**

#### **ELIGIBILITY CRITERIA:**

- a. The Top Scorer in B. Planning and Top Scorer in B. Architecture in the Academic Year 2016 (2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> year students of Planning and 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> & 5<sup>th</sup> year students of Architecture) would be awarded scholarship, provided the students do not have any backlogs or carry over supplementary paper and no case of **Unfair Means Practices**, is reported against the students.
- b. Students with annual gross family income from all sources of Rs. 450,000/- (**Rs. Four Lacs fifty thousand only**) and below would be eligible for applying for scholarship under this scheme.
- c. Students applying under this scheme would be required to substantiate their family income with relevant document declaring their family income by submitting income Certificate for the **financial year 2015-16 issued by the Revenue Authority/Tehsildar**.
- d. The Students should not be recipient of any other scholarship or stipend from any other source.
- e. **All Students are required having bank account in Canara bank only.**
- f. **All Students are required having Aadhar card number link with Canara bank account number.**

#### **How to Apply:**

#### **Merit-Cum-Means Scholarship Scheme:-**

Students are required to apply on application form, (available in Academics Section / or can be downloaded from Institute Web site) along with copies of their score cards and attested copies of income proof certificate for the financial year 2015-16 issued by the revenue authorities.

- Merit-cum-Means Scholarship Affidavit (on 10 Rupees stamp paper) in the prescribed format regarding non-receipt of other scholarship. The format for Affidavit can be downloaded from Institute's website.

**Closing Date:-** Applications along with requisite documents shall reach to Academics Section on or before 30<sup>th</sup> August 2016.
